

CONFIRMATORY PATENT ASSIGNMENT

This Confirmatory Patent Assignment ("**Confirmatory Assignment**") is provided by Gilead Connecticut, Inc., an Affiliate of Gilead Sciences, Inc. ("**Assignor**") to Kronos Bio, Inc., a Delaware corporation ("**Assignee**"). Assignor and Assignee are sometimes referred to herein individually as a "**Party**" and collectively as the "**Parties**". Capitalized terms used herein and not otherwise defined shall have the meaning ascribed to them in the Purchase Agreement (as hereinafter defined).

WHEREAS, Gilead Sciences, Inc. (on behalf of itself and its Affiliates) and Assignee have entered into an Asset Purchase Agreement dated as of July 14, 2020 (as amended, restated or supplemented from time to time, the "**Purchase Agreement**"), pursuant to which, among other things, Gilead Sciences, Inc. (on behalf of itself and its Affiliates) entered into a Patent Assignment Agreement (the "**Patent Assignment Agreement**") dated July 14, 2020 in order to assign to Assignee, its right, title and interest to the patent rights set forth in the Patent Assignment Agreement, which include among other rights the Transferred Patent Rights (as defined below) set forth on Schedule A.

WHEREAS, Assignor is an Affiliate of Gilead Sciences, Inc. and is the assignee of record of the Transferred Patent Rights.

WHEREAS the Parties wish to confirm by this Confirmatory Assignment that Assignor has assigned its right, title and interest to as of the Closing Date to the Transferred Patent Rights to Assignee.

NOW, THEREFORE, in consideration of the mutual promises contained in the Purchase Agreement, the Patent Assignment Agreement and this Confirmatory Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor confirms that it has, and hereby presently sells, assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in and to those patent rights listed on Schedule A hereto, including the right to claim priority from the same in the United States and all foreign countries, and to claim the priority from the same as provided by the Paris Convention, together in each case with all registrations, applications therefor, patents (as applicable) issuing from any applications therefor, and renewals and extensions of the foregoing in the United States and for all foreign countries that are or may be secured under the laws of the United States and all foreign countries, including any division, renewal, continuation in whole or in part, substitution, conversion, reissue, reexamination, prolongation or extension thereof, now or hereafter in effect, for Assignee's own use and enjoyment as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including all claims for damages by reason of past, present or future infringement, misappropriation or other unauthorized use of such patents with the right to sue for and collect the same for Assignee's own use and enjoyment (collectively, the "**Transferred Patent Rights**"). Assignor hereby waives and agrees not to enforce any rights of attribution and integrity and other moral rights Assignor may have in the Transferred Patent Rights.

2. Assignor hereby authorizes and requests the United States Commissioner of Patents and Trademarks and any other applicable government authority to record Assignee as the buyer and owner of the Transferred Patent Rights, and issue any and all registrations thereon to Assignee, as buyer of Assignor's right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee.

3. This Confirmatory Assignment is executed and delivered pursuant to the Purchase Agreement. Nothing in this Confirmatory Assignment, express or implied, is intended to or shall be construed to modify, expand or limit in any way the terms of the Purchase Agreement. To the extent that any provision of this Confirmatory Assignment conflicts or is inconsistent with the terms of the Purchase Agreement, the Purchase Agreement shall govern.

4. If any one or more provisions of this Confirmatory Assignment is held to be invalid, illegal or unenforceable, the affected provisions of this Confirmatory Assignment shall be curtailed and limited only to the extent necessary to bring it within the applicable legal requirements and the validity, legality and enforceability of the remaining provisions of this Confirmatory Assignment shall not in any way be affected or impaired thereby.

5. This Confirmatory Assignment shall bind and inure to the benefit of the successors and permitted assigns of the Parties hereto.

6. Any notice, request or other document to be given hereunder to any Party hereto shall be given in the manner specified in Section 10.5 of the Purchase Agreement.

7. This Confirmatory Assignment may be amended by the Parties hereto at any time by execution of an instrument in writing signed by both Parties. A Party's consent to or waiver, express or implied, of any other Party's breach of its obligations hereunder shall not be deemed to be or construed as a consent to or waiver of any other breach of the same or any other obligations of such breaching Party. A Party's failure to complain of any act, or failure to act, by the other Party, to declare the other Party in default, to insist upon the strict performance of any obligation or condition of this Confirmatory Assignment or to exercise any right or remedy consequent upon a breach thereof, no matter how long such failure continues, shall not constitute a waiver by such Party of its rights hereunder, of any such breach, or of any other obligation or condition. A Party's consent in any one instance shall not limit or waive the necessity to obtain such Party's consent in any future instance and in any event no consent or waiver shall be effective for any purpose hereunder unless such consent or waiver is in writing and signed by the Party granting such consent or waiver.

8. This Confirmatory Assignment and its effect are subject to and shall be construed and enforced in accordance with the law of the State of New York, without regard to its conflicts of laws that would require the application of any other Law. Each of the Parties hereby irrevocably and unconditionally consents to submit to the exclusive jurisdiction of the federal courts located in the Eastern District of the State of New York for any matter arising out of or relating to this Confirmatory Assignment and the transactions contemplated hereby, and agrees not to commence any litigation relating thereto except in such courts. Each of the Parties hereby irrevocably and

unconditionally waives any objection to the laying of venue of any matter arising out of this Confirmatory Assignment or the transactions contemplated hereby in the courts of the State of New York and hereby further irrevocably and unconditionally waives and agrees not to plead or claim in any such court that any such matter brought in any such court has been brought in an inconvenient forum. The Parties agree that a final judgment in any such matter shall be conclusive and may be enforced in other jurisdictions by suits on the judgment or in any other manner provided by law. Any proceeding brought by either Party under this Confirmatory Assignment shall be exclusively conducted in the English language.

9. This Confirmatory Assignment, the other Ancillary Agreements, the Purchase Agreement, the Patent Assignment Agreement, the schedules and exhibits hereto and thereto, the CDA and the documents and instruments and other agreements among the parties thereto and hereto constitute the entire agreement among the Parties with respect to the subject matter hereof and supersede all prior agreements and understandings, both written and oral, among the Parties with respect to the subject matter hereof.

10. This Confirmatory Assignment may be executed in counterparts by a single Party, each of which when taken together shall constitute one and the same agreement, and may be executed through the use of facsimiles or .pdf documents. Counterparts may be delivered via facsimile, electronic mail (including pdf or any electronic signature complying with the U.S. federal ESIGN Act of 2000, Uniform Electronic Transactions Act or other applicable law) or other transmission method and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes.

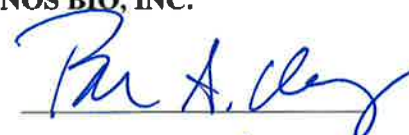
