Publication of European patent applications is a free service that gives you provisional patent protection as a result of the Norwegian Industrial Property Office (NIPO) announcing the claims in its database before the application is granted at the European Patent Office.

Important about EP validation

European patents can be validated in Norway when your European patent (EP patent) has been registered by the EPO. For a granted European patent to apply in Norway, Norway must be designated when the European application is granted. When the patent is published in Norway, we treat it as a national patent.
