WITNESS STATEMENT ROBERT A. DENIKE

- I, Robert A. Denike, the president and Chief Executive Officer of NHS, Inc. having its offices at 104 Bronson Street, #9, Santa Cruz, California, 95062, United States of America.
- The facts in this statement come from my personal knowledge and records of my company and I am duly authorised to speak on my company's behalf in the above matters.
- 3. The purpose of this Witness Statement is to show, via information provided herein and the attached exhibits, the genuine use as per stipulated requirements that for the mark SANTA CRUZ in Norway as at the Relevant Date.
- 4. NHS, Inc. ("NHS") was founded in 1972, and continues to be a large manufacturer, wholesaler and retailer of sporting goods (skateboards), clothing, and sports safety gear and other related goods.
- 5. Since 1973, NHS began to brand its goods under the trademark SANTA CRUZ. NHS owns the following Santa Cruz trademarks, collectively referred to hereinafter as the "Santa Cruz Marks":
 - a. SANTA CRUZ
 - b. JANTA CRUZ

- 6. NHS has distributors and licensees in Europe that have been selling the SANTA CRUZ brand since 1974.
- 7. NHS has 112 active trademarks for our SANTA CRUZ brand in 63 countries, including Norway.
- 8. NHS obtained its Norwegian national trademark registrations for its SANTA CRUZ figurative marks on October 22, 1992 and August 16, 2005.
- SANTA CRUZ was first used in Norway in 1990 for skateboard and accessories and in 1990 for apparel.
- 10. **Exhibit 1** is a collection of numerous invoices dated from 2005 to 2018 for both, hard goods and soft goods sold directly to Norwegian distributors. It can be seen from the Exhibit 1 that NHS's main distributors in Norway are:
 - Balance Distribution A/S (former)
 - Bernhard Sports A/S (former)
 - The Future A/S (Daggers) (current)
 - Shiner Ltd (current)

These distributors would then sell NHS goods to various retailers in Norway. Additional invoices that were issued directly by NHS's distributors and licensees to the retailers in Norway are provided together with other Witness Statements from these distributors.

11. **Exhibit 2** is a table of summarized data that shows the amount of pre-orders of SANTA CRUZ soft goods in different countries.

12. Exhibit 3 consists of copies of excel spreadsheets demonstrating the estimate amount (presented in USD) of sales to each distributor from 2000 to 2018 for all SANTA CRUZ brand products sold in Norway. The total amount of annual sales in Norway through that period reaches approximately € 397 544.

- 13. As regards to the missing data on sales between 2014-2016, this was a transition period of the NHS's distribution channels. Due to explosive popularity and demand for NHS's goods worldwide, NHS had to re-assess its previous distribution strategy and look for bigger alternative distribution channels in order to not miss an opportunity to reach even more customers worldwide. That is why Shiner Ltd, as one of Europe's leading action sports and apparel distributors in Europe, has become our main apparel license and distributor in Europe in 2016. The partnership with Shiner Ltd enabled us to support our loyal customers base with a guaranteed stock holding of essential lines, ensuring timely replenishment. Accordingly, since 2016 our sales for Santa Cruz apparel had increased more than three times.
- 14. **Exhibit 4** consist of copies of the SANTA CRUZ Spring/Summer 2017 and Autumn 2018 apparel catalogues. Please note that the last pages of each catalogue provide a list of NHS's European distributors, including Shiner Ltd and The Future A/S (Daggers). It is my understanding that these companies are providing their own Witness Statements.
- 15. **Exhibit 5** consist of copies of our former licensee's AXL Distribution Ltd. SANTA CRUZ brand products from 2014-2016 that are still available online through the following links:

16. NHS has invested substantial resources in advertising its SANTA CRUZ brand goods throughout the world. Specifically, the estimated total amount spent for advertising the SANTA CRUZ brand in Norway between 2000 and 2018 is approximately €19,798.25, see:

18. The above demonstrates that the SANTA CRUZ brand is the oldest and most well-known "skater brand" in the world, including in Norway, which is supported by the historical and recent sales and marketing activities in Norway.
