PATENTKRAV

1. Et farmasøytisk akivt menneskelig H2 relaksin for bruk som et legemiddel for å behandle dyspné forbundet med akutt hjertesvikt i et menneskelig objekt, hvori objektet har kongestion på røntgenbilde av brystet, forhøyet BNP, et systolisk blodtrykk over 125 mm Hg ved begynnelsen av behandlingen, har en beregnet glomerulus-filtrasjonshastighet (eGFR) på 30-75 ml/min./1,73 m², og hvori den menneskelige H2 relaksin blir administrert ved en intravenøs infusjonshastighet på 30 µg/kg/dag i 48 timer.
