PATENTKRAV

1. Kombinasjon av fytocannabinoidene tetrahydrocannabinol (THC) og cannabidiol (CBD) sammen med temozolomid, for anvendelse i behandlingen av en gliom.
2. Kombinasjonen av fytocannabinoidene THC og CBD sammen med temozolomid for anvendelse ifølge krav 1, hvori kombinasjonen av fytocannabinoidene og temozolomidet pakkes for administrering separat, samtidig eller sekvensielt.
3. Kombinasjonen av fytocannabinoidene THC og CBD sammen med temozolomid for anvendelse ifølge krav 1 eller 2, hvori dosenivået til fytocannabinoidene er undereffektivt for behandlingen av gliomen hvis det anvendes alene.
4. Kombinasjonen av fytocannabinoidene THC og CBD sammen med temozolomidet for anvendelse ifølge kravene 1 til 3, hvori dosenivået til temozolomid er undereffektivt for behandlingen av gliomen hvis det anvendes alene.
