Patentkrav

1. Antistoff som binder alfa-synuklein, omfatter et variabelt domene ved en moden tung kjede med aminosyresekvensen SEQ ID No: 10, et variabelt domene ved en moden lett kjede med aminosyresekvensen SEQ ID No: 5, et konstant domene ved en tung kjede med aminosyresekvensen SEQ ID No. 32 med eller uten det C-terminale lysin, og det konstante domenet ved den lette kjeden har aminosyresekvensen betegnet SEQ ID No: 13.
2. Farmasøytisk blanding som omfatter et antistoff som definert av krav 1.
3. Antistoff ifølge krav 1 for anvendelse som et medikament.
4. Antistoff ifølge krav 1 for anvendelse i behandlingen av en Lewy-legeme-sykdom (LBD).
- 10 5. Antistoff for anvendelse ifølge krav 4, hvori sykdommen er Parkinsons sykdom.
