1. Kjølemiddelsammensetning bestående av en blanding av
fra 94 til 96 vekt% 1,1,1,2-tetrafluoretan,
5 fra 2 til 3 vekt% difluormetan og
fra 2 til 3 vekt% pentafluoretan.

2. Kjølemiddelsammensetning ifølge krav 1, hvor difluormetanet og
pentafluoretanet har et blandingsforhold fra 45 til 55 vekt% difluormetan og fra 55 til
10 45 vekt% pentafluoretan.

3. Anvendelse av kjølemiddelblandingen ifølge et hvilket som helst av kravene 1
til 2 i klimaanlegg og varmepumper.
