## **Patentkrav**

1. Tapentadol for anvendelse i behandling av depresjon og/eller angst hos et individ som lider av kronisk giktsmerte, under forutsetning av at tapentadol ikke administreres i kombinasjon med et antiepileptikum.
2. Tapentadol for anvendelse ifølge krav 1, under forutsetning av at tapentadol ikke administreres i kombinasjon med en AMPA-reseptorantagonist.
3. Tapentadol for anvendelse ifølge krav 1 eller 2, hvori tapentadol administreres som eneste farmakologisk aktive ingrediens.
4. Tapentadol for anvendelse ifølge hvilke som helst av de foregående kravene, hvori tapentadol administreres oralt.
5. Tapentadol for anvendelse ifølge hvilke son helst av de foregående kravene, hvori tapentadol administreres
  - én gang daglig eller to ganger daglig, og/eller
  - i en daglig dose innenfor området fra 25 til 600 mg.
6. Tapentadol for anvendelse ifølge hvilke som helst av de foregående kravene, hvori smerten er moderat til sterkt.
